



**SPECIAL EVENT NOTICE 3/325 MARKET PLACE CIRENCESTER  
PARISH COTSWOLD DISTRICT**

Gloucestershire County Council has made an Order to close temporarily under Section 16A of the Road Traffic Regulation Act, 1984, (as amended by the Road Traffic Regulation (Special Events) Act 1994) 3/325 Market Place because it is satisfied that the use of the said highway should be prohibited for the purpose of facilitating the holding of a relevant event namely the Cirencester Christmas Market.

The highway falls within the Parish of Cirencester in the Cotswold District Gloucestershire.

There will be a partial exemption to allow LGV (vehicles under 7.5 tonnes) to load/unload outside 34-38 Market Place.

The Order comes into force on 26<sup>th</sup> November 2012 till 17<sup>th</sup> December 2012.

**Alternative Route – Exiting Market Place via Dyer Street**

Via 3/325 Dyer Street, 3/325 London Road, A429 Swindon Road, A429 Bristol Road, 3/181 Hammond Way, 3/181 Tetbury Road, 3/181 Park Lane, 3/181 Park Street, 3/181 Silver Street and 3/181 Castle Street  
And as signed on site.

**Alternative Route – Exiting Market Place via Castle Street**

Via 3/181 Castle Street, 3/181 Sheep Street, 3/181 Hammond Way, A429 Bristol Road, A429 Swindon Road, 3/325 London Road, 3/325 Lewis Lane, 407205 Southway and 407204 Northway  
And as signed on site.

Pedestrian access to premises on or next to the road and emergency access will be maintained.

**TEMPORARY CLOSURE OF 3/325 MARKET PLACE CIRENCESTER**  
**COTSWOLD SPECIAL EVENT ORDER 2012**

WHEREAS the Gloucestershire County Council ("the Council") being the Traffic Authority for 3/325 Market Place ("the Road") and having obtained the necessary consent from the Secretary of State for Transport for the Order to permit the closure of the road for more than three days ("the Consent") is satisfied that traffic along the length of the Road as defined in Article 1 below should be prohibited for the purpose of facilitating the holding of a relevant event namely Cirencester Christmas Market.

NOW THEREFORE the Council in exercise of its powers under Section 16A of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic Regulation (Special Events) Act 1994), hereby makes with the Consent the following Order:-

1. Except for pedestrian access to premises situated on or adjacent to the Road no person shall proceed nor cause or permit a vehicle to proceed along 3/325 Market Place from the junction with Cricklade Street/Castle Street to the junction with Northway/Dyer Street, a total distance of approximately 200 metres
2. There will be a partial exemption to allow LGV (vehicles under 7.5 tonnes) to load/unload outside 34-38 Market Place
3. This Order shall come into force on the 26<sup>th</sup> day of November Two Thousand and Twelve and shall continue in force until 17<sup>th</sup> day of December Two Thousand and Twelve
4. Nothing in Article 1 shall render it unlawful for a vehicle being used for Police, Fire Brigade or Ambulance purposes to proceed along the Road
5. Nothing in Article 1 shall render it unlawful for a vehicle being used by a statutory undertaker responding to an emergency situation to proceed along the Road
6. This Order may be cited as the "Gloucestershire County Council Temporary Closure of 3/325 Market Place Cirencester Cotswold, Special Event Order 2012"
